



PROCLAMATION 01-17-2017 (A)

A PROCLAMATION CALLING AN ELECTION FOR THE OFFICES OF COUNCILMAN FOR WARDS 1, 2, 3 AND 4 FOR TUESDAY, APRIL 4, 2017, IN THE CITY OF THE VILLAGE, OKLAHOMA; PROVIDING FILING DATES AND METHODS OF FILING FOR SAID OFFICES PROVIDING FOR QUALIFICATIONS FOR SAID OFFICES AND LISTING THE POLLING PLACES.

BE IT ORDAINED BY THE MAYOR OF THE CITY OF THE VILLAGE, OKLAHOMA:

Section 1. An election is hereby called for the offices of Councilman in Wards 1, 2 and 3 in the City of The Village, Oklahoma for Tuesday, April 4, 2017. The Council Members elected to seats for Wards 1, 2 and 3 shall serve for a two (2) year term beginning at 7:30 p.m. on May 1, 2015.

Section 2. An election is hereby called for the office of Councilman in Ward 4 in the City of The Village, Oklahoma for Tuesday, April 4, 2017. The Council Member elected to the seat for Wards 4 shall serve for a one (1) year term beginning at 7:30 p.m. on May 1, 2017.

Section 3. Each Councilman will be elected at large by the registered, qualified electors of the entire City of The Village, Oklahoma voting in their respective Wards but the candidates for the Council positions must be qualified electors in their respective Wards. The candidate receiving more votes than any other candidate for each office shall be elected.

Section 4. Any person qualified as an elector in his respective Ward may have his or her name placed on the ballot as a candidate for Councilman from said Ward by properly filing and paying a filing fee of fifty (\$50.00) dollars at the Oklahoma County Election Board, Oklahoma City, Oklahoma, during the filing period, which begins at 8 o'clock a.m. Tuesday, February 21, 2017, and ends at 5 o'clock p.m. on Thursday, February 23, 2017.

Section 5. The election will be conducted by the Oklahoma County Election Board.

Section 5. The designated polling places for the election shall be as follows:

- *Precinct 550102: Christ The King, 8005 Dorset Drive.*
- *Precinct 550103: Britton Road Church of Christ, 2520 W. Britton Rd*
- *Precinct 550104: Northside YMCA, 10000 N. Pennsylvania Avenue.*
- *Precinct 550105: Village Christian Church, 9401 N. Ridgeview Drive*
- *Precinct 550106: Our Lord's Lutheran Church, 2900 W. Hefner Road.*

Section 6. The City Manager is hereby directed to provide a copy of this Proclamation, a copy of the City Charter, and map of the City of The Village, Oklahoma, to the County Election Board Secretary as provided by law.
